

XII. <u>RCM Report</u> The RSC met on January 15-16 in Hollywood. Evelyn and I attended various subcommittee meetings on Saturday and the RSC meeting on Sunday. The minutes include a financial report and minutes from the convention board that we have been requesting for quite some time. Thanks go out to Stewart for providing this information.

Some decisions were made at that RSC meeting as follows:

- The RSC voted to send our Alternate Delegate to Wichita in March to find out what is going on with the proposed US Service Conference at a cost to the region of \$300. This motion was time sensitive, so it could not be sent back to the groups for a vote.

- The RSC voted to provide \$900 for the Broward County bus ads. This was approved so as to avoid any interruption in the bus ads which would have resulted in a higher cost to re-start the ads.

- The RSC voted to provide \$100 to the North Dade Helpline as that area has limited funds.

- The RSC travel policy for travel under 85 miles was changed from .40 per mile to .30

There are also motions that were sent back to the groups that will need to be voted on and these motions will be attached as a separate addendum to the ASC minutes.
