

## RCM REPORT - NEXT PAGE

**RCM REPORT** - There are 13 motions from Region that will need to be voted on by the groups and brought to the next ASC meeting.

The South Florida RSC met on Sept 17-18 in Naples. There were 10 out of 11 areas present. All GSR's should have received via e-mail the RSC minutes and a SFRCNA financial report prior to this past ASC. Anyone needing to review RSC minutes can do so from the RSC website at <a href="https://www.soflarscna.org">www.soflarscna.org</a>. The login to download the minutes is sfrsc and the password is Honesty1.

Since everyone should have already received the RSC minutes, I'll just give a brief synopsis of some of the items that are going on in our region. We now have an active Literature Committee for the first time in almost two years. They are currently reviewing a new service pamphlet released by the World Board titled "Social Media." Our region received a case of books from the East Coast Convention for distribution into our local prisons. These were distributed to the RCM's and I have given books to our H&I chair to get into the Broward County jail. Our newsletter was printed and I will distribute these at our next ASC meeting (they were left at home. Sorry!!) The PR committee continues to do outstanding work and are currently working with the life skills programs in the jail system for prisoners set to be released and integrated back into their local communities. There are two motions going back to the groups concerning the funding of literature for that program. The South Florida Regional Convention reported a profit of approximately \$10,000 from SFRCNA 16. I'd like to thank all the members from the South Broward area for their hard work, both as members of the host committee and as members of our Board of Directors. and also those who came to the convention to make it such an outstanding success. The service system ad-hoc committee continues to hold workshops around our region to help members get the current information on the service system project.

There are 12 motions that are coming from the RSC that need the groups to get a conscience on, including 7 budget motions. These motions are included at the end of this report. If anyone has any questions on any of these motions, please feel free to call me, and I'll help you out as best I can. My phone number is included at the beginning of the ASC minutes.

As a heads up, GSR's should start preparing for the Conference Agenda Report (CAR), which is due to be released on November 25 and is the items dealt in old business at the World Service Conference. This CAR will include some very important items that will need to be voted on by each group. These items include a new book called "Living Clean" and motions to approve in principle major changes to our local service structure as well as the entire service structure. Once the price of the CAR has been set, I will make a motion that each GSR be provided one copy. It will then be up to the GSR's to gather the conscience of their group on each of the items contained in the Conference Agenda Report.

Our region has a different method for gathering group conscience on the Conference Approval Track (CAT), which are the new business items voted on at the World Service Conference. Since the CAT is not released until the end of January, our region holds a workshop at the March RSC, and all those who attend the CAT workshop are the ones who give our Regional and Alternate Delegates the direction on how to proceed with those items.

Our region is \$3,936.84 above prudent reserve and a motion was made and passed to donate \$900.00 to World Service.

Our next RSC will be held in the South Dade area on November 19-20. It will be at the Holiday Inn in Miami Springs, 1111 South Royal Poinciana Blvd. Rooms are \$109 per night and can be booked by calling 786-369-7667.

After researching archived financial data, we found that the SFRCNA convention has averaged \$9600 profit for the past 10 years. We have roughly \$4000 a year in expenses. (I.e. bank fees, storage fees, credit card machine fees, meeting space rental fees, and travel expenses) We can only project expenses based on previous years. The actual expenses may be lower if meeting frequency changes. How this motion would effect the terms of the BOD members is it would require a 4 year commitment. It would also require at least a 3 year commitment for the Host committee. I and the other board members also think that another thing to be considered is the unity experienced by the newcomer and other NA members at our regional convention. I, for one experienced my first NA convention at SFRCNA in Doral and have always looked forward to the love that I feel from fellow addicts at this great event. This is just one of the great tools we have to carry the message of hope to other addicts. We also feel that the continuity of the convention would suffer greatly by having it every other year. We are but trusted servants and do our best. # The relationship of Narcotics Anonymous to NarAnon and Families Anonymous

This article was generated by the World Service Board of Trustees in August 1987 in response to the

needs of the fellowship. It represents the views of the board at the time of writing. The World Service Board of Trustees has received many inquiries during the past few years which have asked specific questions about how to go about cooperating without affiliating when it comes to NarAnon and Families Anonymous. The need to address this issue arose from a confusion between the letter of our Twelve Traditions, and the spirit of love, understanding, and caring which we all feel as individuals.

It has become clear to us that the phrase "cooperation not affiliation" is no longer suitable for Narcotics Anonymous. Undoubtedly this attitude and these words have served us over many years, but it appears that the growth and development of our fellowship demands a revised expression. In consulting the dictionary, "cooperation" means "the act of working together to a common end or the association of a number of people together in an enterprise, the benefits of which are shared." This definition can present a problem in addressing our relationship with any other organization, including NarAnon and Families Anonymous. Strictly speaking, the object or goal of our fellowship is not the same as any other fellowship. In this respect, it is impossible to cooperate without also endorsing or affiliating.

The World Service Board of Trustees believes that a policy, or attitude, or phrase which serves our purpose best and guides our fellowship well is "a policy of non-affiliation." This clearly conveys the fact that we do not associate with, connect with, or adopt any other organization or purpose. Traditions Six and Ten refer to these issues, and there can never be any formal relationship between Narcotics Anonymous and any other fellowship or organization. As individuals, we have tremendous respect for these other fellowships and support the need for them. As grateful recovering addicts, we carry intense and genuine love and understanding in our hearts. Adherence to our Twelve Traditions does not preclude or negate these feelings. We must remember, however, that Narcotics Anonymous, NarAnon, and Families Anonymous are separate fellowships, each with their own purpose. These organizations are not enmeshed with each other nor are they interdependent. We believe that by reflecting back upon our own paths, we can find the way to convey this respect, love, and support, without endorsing or affiliating with other fellowships. Our family members and loved ones were often instrumental in allowing us to face the consequences of our addiction by not helping us! We now have the opportunity to support them by not interfering and also by simply pursuing our own purpose as guided by the spiritual principles of Narcotics Anonymous. While we all may have our own way of supporting our loved ones, NA can only remain true to our primary purpose and the guidance provided in Traditions Six and Ten. Consistent fellowship action which is guided by these principles is the kindest and most loving path for us to follow, both for ourselves and our family members and loved ones. This helps these other

fellowships to address their own needs in a sensible, appropriate, and non-dependent manner.

Our relationship as a fellowship with NarAnon and Families Anonymous, as with treatment centers, clubhouses, or any other organization or enterprise, can then be simply and clearly defined as one of providing information. We provide--and will continue to provide--information about what we do, where we do it, where our meetings and conventions are held, etc., to anyone who asks for it. At the same time, we avoid any type of affiliation or special treatment for any people or organization outside of Narcotics Anonymous.

The World Service Board of Trustees believes that many of the practices in which we have engaged as a fellowship run counter to our traditions. The intent of these actions was usually sound, and it has taken many years of experience and study to evaluate them with respect to our Twelve Traditions. These include listing Families Anonymous and NarAnon meetings in NA directories, on flyers for NA conventions, or in NA registration forms, and the practice of obtaining meeting places for these other fellowships at conventions or other NA activities. Additionally, utilizing speakers from the NarAnon and Families Anonymous Fellowships is a practice which does not adhere to our traditions. However, we encourage phoneline workers to use common sense and good judgment in making known to family members that NA is for the drug addict and that family members may find family oriented recovery fellowships to be beneficial.
