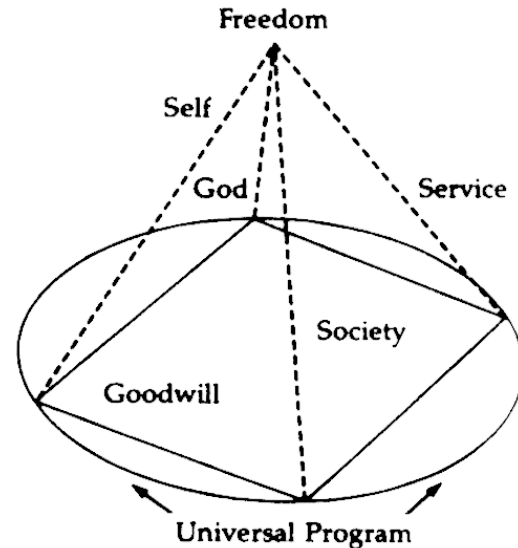
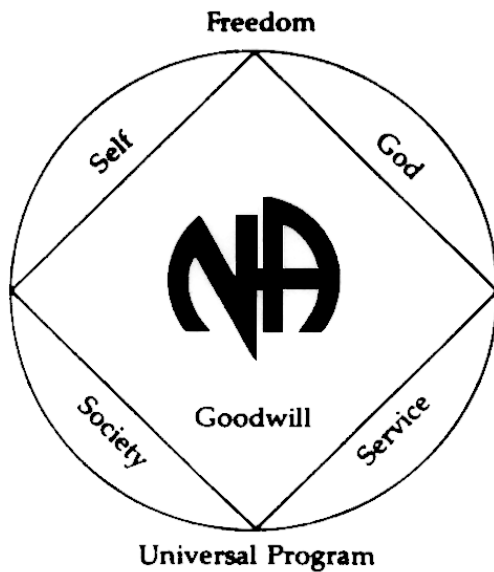

XII. RCM Report I attended, along with Evelyn the last RSC held in the Gold Coast Area. I went to the SFRC Board meeting, the Service System workshop and the Admin committee meeting on Saturday as well as the RSC meeting on Sunday. The following are some of the items from that weekend:

- New literature available – The new self support IP’s are now available from World. They are IP#24 – Money Matters, Self Support in NA and IP#28 – Funding NA Services. These were the pamphlets voted on in the Conference Agenda Report and replace the existing self support IP and the IP “Hey, What’s the Basket For.”
- Fellowship Literature Survey – There is a fellowship literature survey available online for all those who wish to participate in it. It is located at www.na.org/litsurvey
- Living Clean Project – This book length piece of literature being worked on is in it’s final stages. The last two chapters and the preface are currently being reviewed and input is due by December 31. Information for this project can be found at www.na.org/livingclean
- WCNA 34 – The next world convention will be held in San Diego from Sept 1-4, 2011. Everyone planning on attending will need to preregister.
- PR – The region passed the motion for the interior bus ads for Miami Dade County. There is loads of PR going on in our region, including our bus ads in Broward County, billboards in the Keys and PSA’s airing on Comcast in the Keys and on the West Coast.
- The following motions were passed at the last RSC. A motion to change the SFCNA BOD purpose. This was done for tax purposes so we could continue working on applying for non-profit status. The RSC travel policy was reduced to .30 per mile for travel over 85 miles. A motion was also passed to change the policy concerning the dates of the regional convention so that it will be held on Labor Day weekend except when the World Convention is held in North America. Previously, that policy was Labor Day except when the World Convention is in our zone. When this motion came up, I should have motioned to send this back to the groups, since it is our members who attend the convention, and they should have the ultimate authority as to when the convention should be. I screwed up. I will try, at the next RSC, to have this issue sent back to the groups for a vote.
- A donation was made to the World from our region in the amount of \$4,812.55. This was the amount in excess of our prudent reserve of \$5,000.

- **The following regional motion needs to be voted on by the groups: Motion 090110: To remove the RSC travel policy guideline on Page 19 RSC #2 which states “If they travel less than 85 miles each way and use their own car or transportation may be reimbursed at the current federal mileage rate as of RSC per mile.” Intent: To remove portion of RSC policy that reimburses RSC trusted servants for travel under 85 miles each way. Our areas don’t do this and neither should our region.**

XIII. Alt RCM On November 20 & 21, 2010, I attended the November Regional Service Committee Meeting. There were 10 Areas represented. On Saturday I attended the SFRCA BOD meeting. I brought to their attention that our Area would be sending back a motion to request copies of the minutes and other items of clarity for the Groups information. I will attach a copy of the Regional minutes to my report for the review of the Groups. Adrian K of South Broward was nominated to the SFRCA BOD. Minutes of the Region can be found at

At the RSC meeting on Sunday, the following issues were among those discussed:

- Most RCM's gave an Area report of activities and issues and /or concerns.
- The RCM from So. Broward, Jeff P. brought to the group's attention that our area engaged in discussion about the dates chosen by the 2010 BOD for the 2011 Convention, noting that certain members feel that the decision violated RSC Policy. He also noted that certain members would like to have the minutes of the BOD and Host Committee meetings made available to the fellowship including clear and detailed financial information.
- The RD & AD spoke on the World Service System workshop recently held in Orlando. A request was made to all groups who have received a certificate of insurance for the facility where they hold their meetings to provide that information to the RCM, Jeff.
- The various sub committees provided detailed reports. This included the SFRCNA BOD with a budget proposal for 2010-2011. The Budget shows the proposed budget for 2 prior years but alternate RCM would like to see the submitted budget revised to show the actuals for the two prior years with the proposed for 2010-2011. This would provide a better comparison for considering the proposed budget for 2010-2011. The next RSC will be held in January 15 & 16 in Hollywood at the Marriott on the Beach.

Last month at Area, in the absence of the RCM and any Convention committee members, certain requests for information were directed to me, as Alternate RCM, by members on the floor. It has since come to my attention that the information being requested was already provided in some detail in the September RSC report that was provided to RCMs. I replicate that information here:

UNFORTUNATELY OUR FINANCIAL NUMBERS WERE NOT WHAT WE HAD HOPED. WE ARE SHOWING A LOSS OF \$-4,412.13.

UNFORTUNATELY OUR MERCHANDISE DID NOT SELL WELL. THIS HURT US CONSIDERABLY FINCIALLY. WE DO HAVE APPROXIMATELY \$2,100 WORTH OF MERCHANDISE TO SELL – THIS AMOUNT IS OUR COST. WE WILL BE SELLING THIS AT ALL FUNDRAISERS AND EVENTS WHERE EVER POSSIBLE. WE DID HAVE A SUCCESSFUL HOST COMMITTEE ELECTION FOR SFRCNA 17 AT THE CONVENTION AND THEY ARE STARTING TO WORK ON NEXT YEARS CONVENTION. WE ARE ALSO IN DESPERATE NEED OF BOARD MEMBERS. STARTING IN NOVEMBER WE WILL BE DOWN TO 6 MEMBERS. 11 IS A FULL BOARD. IF YOU KNOW ANYONE THAT HAS ANY INTEREST PLEASE HAVE THEM COME AND CHECK OUT OUR NEXT MEETING WHICH WILL BE

ON OCTOBER 9TH AT 1:00 AT THE BACK ON TRACK CLUBHOUSE LOCATED AT 20377 N.E. 15TH COURT , MIAMI.

WE ARE MOVING FORWARD WITH THE 501C3 / TAX EXEMPT PAPERWORK. IT WAS PUT ON HOLD UNTIL AFTER THE CONVENTION DUE TO THE FINANCIAL COST OF IT. THIS HAS BEEN A TOPIC IN THE WORKS FOR OVER 5 YEARS AND IT IS TIME FOR IT TO GET DONE. IT WILL SAVE US CONSIDERABLE MONEY ONCE WE GET THE EXEMPT STATUS. THE TOTAL COST OF THIS WILL BE APPROXIMATELY \$1,500. THIS INCLUDES ALL FILING FEES AND SPECIAL WORKER FEES.

THE BOARD WOULD LIKE TO LET THE REGION KNOW WE ARE IN THE PROCESS OF DOING A COMPLETE OVERHAUL ON THE BUDGET FOR 2011. WE FEEL IT'S TIME TO MAKE MAJOR CUT BACKS, EVEN MORE THAN WE DID LAST YEAR. WITH THE ECONOMY STILL IN THE STATE IT IS IN. WE BELIEVE THE RESPONSIBLE THING TO DO IS TAKE A CLOSE LOOK AT ALL THE EXPENSES AND SEE WHAT WE CAN SUBSTANTIALLY CUT.

IT HAS BEEN BROUGHT TO MY ATTENTION THE REGION WOULD LIKE OUR MINUTES AND FINANCIAL REPORTS TO BE INCLUDED IN OUR REPORTS. I WILL BE HAPPY TO DO THIS AND WILL SEND EVERYTHING TO THE REGIONAL SECRETARY TO BE PUT INTO THE REGIONAL MINUTES.

ON A PERSONAL NOTE THIS WILL BE MY LAST REGION REPRESENTING THE SFRCA BOD. IT HAS BEEN A GREAT HONOR TO SERVE THIS REGION. IT IS TIME FOR ME TO TAKE A BREAK FROM THE BOARD AS MY 2 YEAR POSITION IS UP IN OCTOBER. I HAVE A LOT OF TOUGH LIFE GOING ON RIGHT NOW AND FEEL THE BEST PLACE FOR ME TO SERVE IS AT MY HOMEGROUP.

To address the issue of conflict regarding convention dates the following motion was passed at Region:

Motion# 111110 Maker: Gulf Coast 2nd by: South Broward

Motion to Read: To change policy page 19 (1x) (F) from "SFRCA should take place during labor day weekend on a permanent basis from 1998 forward. When WCNA is in our zone, SFRCA will move its date to accommodate the world convention. SFRCA shall take place during Labor Day weekend except when WCNA is in North America.

Intent: To change the policy so that we don't hold SFRCA on a date when many go to WCNA.

Passed 6/0/1

Additionally, being new to the position of Alternate RCM and new to the SFRCA Convention and Host Committees, I have since determined that the selection of the date for this year's event was made by last year's committee and Board, not this year's Host Committee, as I heard inferred. The members on the floor were involved with the convention activities including the selection of date and location and were far more aware of the actions taken to select the date for this year than was I. I find doing service in an unloving and adversarial atmosphere concerning. I have asked that representatives from the BOD and the Host Committee come to this ASC meeting to address the questions from the floor.

I attended our Regional H & I Subcommittee meeting on Saturday, Nov. 19, 2010. We discussed some issues regarding the Broward County jail Meetings. A representative from the Jail system was present and we have agreed to schedule a meeting with the Jail coordinators and each Area H & I Chair to resolve some of these issues. Further, I was elected secretary of the Regional H & I Subcommittee, and am honored for the opportunity to be of further service to H & I.

I regret that our Vice Chair, Dan K., has stepped down from his position due to personal circumstances, and we are in need of a new Vice Chair.

Further, for the last three months, our monthly subcommittee meeting has not met quorum and although we voted to waive quorum, it continues to be an issue that panel chairs are not showing up for our monthly meeting. In our Guidelines it states, that one must call or attend, and that anyone who fails to do so for three consecutive months will be asked to leave their position. This system is not working, as we have lost communication with several panel chairs. The committee has decided to collectively visit some of these H & I meetings unannounced to see what is going on there. I discussed this issue at Region, and was given the suggestion to take out the word "call" from the policy. However, since this would be a policy change, a motion would need to come from a GSR and if passed, would have to go back to the groups.
