II – R.S.C. MEETINGS (REGIONAL WEEKEND)

A. GENERAL

- 5) In the Regional Weekend Schedule, a Friday night 10 PM Welcome meeting shall be included, to be held at the same locality of the RSC, if possible; otherwise, indicate a local Friday night meeting. The purpose for this meeting and its scheduled time is so that Regional Trusted Servants have an opportunity to share their experiences at their personal recovery level, rather than at their service level, to help us get to better know each other as “fellow-addicts”, in order to hopefully improve our communications at the “service level”.
- 6) There should be a Recovery Meeting prior to the Saturday night activity.
- 7) The Saturday night activities that have proven popular in the past are: Dances, Coffee Shops and Auctions. Activities that have been controversial are Bikini Contests. Care should be taken to select an activity that is in accordance with the 12 Traditions of NA. Often, many newcomers attend Regional Activities. We must remain attractive as a Fellowship.
- 8) Every November Regional is designated for a RCM Learning Day.
- 9) Hurricane Contingency Plans: if a hurricane warning has been issued for an area where the RSC weekend has been scheduled, the following must take place.
 - a. RCM or Hotel Liaison must contact the Vice Chair or Chair of the South Florida Region to update them on the current situation.
 - b. Chair will instruct the RCM or Hotel Liaison to contact the hotel about the Act of God Clause if a hurricane will strike the area or an evacuation is ordered.
 - c. At the earliest time possible the RCM or Hotel Liaison will inform the Chair of an evacuation and then the Chair will cancel the RSC weekend.
 - d. Chair will call the Secretary and he/she will contact the RCMs in the Region and inform them of the cancellation.
 - e. Chair will instruct the Public Relations Committee Chair to place a message on the Regional Helpline Number (in an additional mail box) to further inform the fellowship of the cancellation.
 - f. If a new date can be set, Admin will then make a decision if the RSC can meet. If not, the Admin Committee may meet for the purpose of paying bills. The location will be announced to the RCMs at least two weeks prior to the meeting.
 - g. If an Area has been hit by a hurricane, the Chair or Vice Chair will contact the RCM to see if the South Florida Region can be of any assistance. The Chair or Vice Chair will then direct the Public Relations Chair to add an additional mailbox on the Regional Public Relations number for contact information during the Area’s emergency. It will be the RSC Chair’s discretion to list what type of information on the mailbox, i.e. meeting location, ASC location, or other contact information.

B. HOST AREA

- 1) The RSC Weekend shall rotate among the member Areas starting in odd calendar years as follows:

January – South Broward
March – Gold Coast
May – SFRC
July – Sunset Coast
September – Mid Coast
November – Gulf Coast
January – South Dade
March – North Dade
May – SFRC
July – Conch Republic
September – Beach & Bay
November – Shark Coast

Areas must give Administrative Service Committee the required details as per questionnaire provided by the Administrative Service Committee of the complete intended set up for it, four months prior to the weekend they are scheduled to host the RSC. The Administrative Service Committee will then either approve it or send it back to the host area committee with suggestions for changes.

- 2) The Activities subcommittee will prepare a flyer, with all details of the RSC, including schedule of meetings, directions and map, and facilitate it to the Regional Activities Subcommittee, so that it is included in the Regional Activities Calendar Mail-Out.
- 3) It will be the responsibility of each Subcommittee Chair to notify the Administrative Service Committee of any changes or additions on the meeting time of his/her respective Subcommittee.
- 4) Should an Area be unable to host the RSC for any reason, the responsibility shall then be for the Admin. Subcommittee to host the weekend at the most feasible location.
- 5) Any area requesting a workshop from the RSC subcommittees or admin must submit their request to the administrative committee 2 regions prior to the date of the required workshop. The area must include this request in their written report to be read on the floor at the RSC

C. SITE

- 1) Our experience has shown that it is preferable to hold an RSC at a hotel. These are some of the reasons:
 - a) Unity: Everyone is together in same place.
 - b) It may offer a central place for fund-raiser.
 - c) “Cool” place to hang out
 - d) Encourages attendance.

A. GENERAL

- 5) There will be a Friday night, 10:00 pm welcome meeting to be held at the same location as RSC, if possible, otherwise to be held at a local Friday night meeting.(CL) The purpose for this meeting and its scheduled time is so that Regional Trusted Servants have an opportunity to share their experiences at their personal recovery level.
- 6) There should be a Recovery Meeting prior to the Saturday night activity.
- 7) Every November RSC (CL) is designated for a RCM Learning Day.
- 8) Hurricane Contingency Plans: if a hurricane warning has been issued for an area where the RSC weekend has been scheduled, the following must take place by the hosting RCM: (CL)
 - a. RCM or Hotel Liaison must contact the Chair or Vice Chair (CL)of the RSC (CL) (to update them on the current situation.

- b. RSC Chair or Vice Chair (CL) will instruct the RCM or Hotel Liaison to contact the hotel about the Act of God Clause if a hurricane will strike the area or an evacuation is ordered.
- c. At the earliest possible (CL) time the RCM or Hotel Liaison will inform the RSC Chair or Vice Chair of an evacuation who will then cancel RSC weekend (CL)
- d. RSC (CL) Chair or Vice Chair (CL) will contact the Secretary to inform the (CL) RCMs of the cancellation.
- e. The RSC (CL) Chair or Vice Chair (CL) will instruct the PR Chair to update the regional helpline to inform the fellowship of this cancellation. (CL)

(relocated to additional guidelines as I under number X page 21) How to be rewritten in other section “If a hurricane effects any area within our region the RSC chair of vice chair will contact the affected areas RCMs to see how we, as a region, can be of assistance. The chair or vice chair will direct the PR chair to add information to the regional helpline. (moved language)

- 9) Should an Area be unable to host the RSC for any reason, the responsibility shall then be for the Admin. Subcommittee (DL) to host the weekend at the most feasible location.
- 10) Any area requesting a workshop from the RSC subcommittees or admin must submit their request to the administrative committee 2 regions (DL) four months (CL) prior to the date of the required workshop. The area must include this request in their written report to be read on the floor at the RSC
