Policy Committee – No written report submitted.

Area Inventory Ad-Hoc Committee Report July 11, 2010 (Copy of Inventory to be emailed separately)

The inventory process took four months for our Area to complete. Every GSR and Area Trusted Servant received an inventory form. I received 20 responses in total and have tallied the results. The answers to the questions were based on the following scale:

- 1 = Not at all
- 2 = Needs Improvement
- 3 = Adequate
- 4 = Outstanding
- 5 = Excellent

The results were derived by adding the numbers for each question and then dividing the total by the number of responses to that question (not every question was responded to on every questionnaire).

The lowest score was for the question: "How fully does the Area train and support members who serve on the ASC?"

Two questions tied for the second lowest score:

"How well does the ASC foster an atmosphere of courtesy and mutual respect?"

"How well is a sense of unity fostered within the area service body?"

These low scores may provide a clue as to why we struggle to meet quorum in our ASC meetings.

The last question that achieved a score under 2.5 was: "How well does the area communicate with local groups?"

The six questions at the end of the survey regarding communications with Region and NA World Services have the distinction of being **both** the questions that earned the highest scores **and** the questions with the most non-responses, indicating that we may have an issue with communications of all kinds. According to the Area Planning Tool (from which this questionnaire comes), the next step is "Developing Goals." Goals should be clear, concise, and result-oriented statements that are achievable.

The goal should be an outcome or a result. For example, the goals for training and supporting members who serve on the ASC might be regularly scheduled learning days, overlapping terms for all trusted servants, GSR orientation, and having area support available to train group-level trusted servants. Coming up with goals could be using the "small group" approach or having it done by area admin. It is now up to the GSRs to determine how they want to proceed with this inventory process .ILS, Jeff P.
